

Planning Unit 087244 Forest Harvest Plan

1. Introduction

This Forest Harvest Plan (FHP) for Planning Unit 087244 includes maps and reports that clearly show and document the planned harvest area boundaries, roads and water crossings within the planning unit.

This plan is being submitted for appraisal, for a 5-year FHP approval under the 2017-18 Alberta-Pacific Forest Industries Inc. (Alberta-Pacific) Annual Operating Plan (AOP).

This FHP has been discussed with Alberta Agriculture and Forestry (AAF).

2. Planning Unit Specific Comments

Planning Unit 087244 is located north of Wabasca. The Wabasca River borders the east side of the planning unit and the Woodenhouse River borders the west side of the planning unit.

The planning unit is located in Forest Management Unit (FMU) S22. Alberta-Pacific has rights to D and DC as deciduous landbase and CD and C as shared coniferous landbase.

This plan contains both laidout and non-laidout blocks. The laidout blocks are being submitted for a five-year approval. These blocks will be referred to as FHP blocks. The non-laidout blocks are included within this plan for information purposes only and will be amended to the FHP once they have been laidout. These blocks will have a number 2 at the end of the block number.

Integration

Since this FHP is in FMU S22 it has been provided for review to Vanderwell Contractors (1971) Ltd.

Alberta-Pacific has received their agreement for this plan on October 20, 2017.

Watershed

The Wabasca river along the east boundary of the planning unit and the Woodenhouse River on the west are fish bearing and navigable water ways. They will be buffered accordingly.

All unsurveyed channeled creeks have been buffered and crossed as though they were fish bearing.

Stand Structure

An average of 5% of the merchantable volume will be left in stand structure over the FMU. The structure will be left as laidout patches, and as single trees and small clumps of timber at the operators' discretion.

Stand structure has been planned (delineated) in the larger blocks to create larger residual areas. These areas are identified as Retention Areas (RAs) within the lists and on the maps. These blocks have a 9 at the end of the block number.

Debris Management

All of the blocks in this unit are outside FireSmart Community Zones as identified by Alberta Agriculture and Forestry (AAF). One or more of the following debris management strategies apply for blocks within this planning unit:

- Methods described in the Forest and Prairie Protection Act and Regulations, and/or
- Thinly spread slash throughout the block.

Blocks within this planning unit will not utilize the retention of debris piles as a management strategy.

The deciduous utilization standard will be 15/10. The coniferous utilization standard will be 15/11.

Design Comments

During the layout phase of this operation, Alberta-Pacific looked for signs of insect or disease infestations. No significant signs were detected.

In the above tables, possible "Field Call" channelled watercourse classifications are ephemeral (E), intermittent (I), transitional (T), beaver pond (B), small permanent (SP) large permanent (LP), or no channelled watercourse (NW). The "Navigability" rating identifies channelled watercourse as being potentially navigable (N) or potentially unnavigable (U) based on the possibility of traveling the stream with a vessel. The "Field Call" channelled watercourse classifications in the above table are based on Table 1 of the OGRs at the time, and during the conditions, when layout was conducted.

Forest Recreation Groups

There are currently no active forest recreation groups with interests within this planning unit.

Historical Resources

Known historical resource sites have been addressed during the design of this plan. Lands on which historical resource sites are likely to occur will be checked prior to commencement of operations.

Forest Aesthetics

No concerns have been indentified.

Land Use

As per a review of the Alberta Government's Digital Integrated Dispositions (DIDs) digital mapping program on August 10, 2017 and Alberta-Pacific's Landuse files from Evergreen Land Use Consulting on August 25, 2015, there are currently no dispositions within this planning unit that restrict the harvesting timber.

A roadside development permit was approved on September 29, 2017 to allow timber harvesting on RDS110039 in SE31, SW31, SE36 Township 87, Range 23 and 24 W4M. This permit expires on March 31, 2019.

Wildlife

Portions of the planning unit is within Caribou Range. Operations will adhere to the Alberta-Pacific Caribou Protection Plan submitted annually in the fall.

Portions of the planning unit are within a key Wildlife and Biodiversity Zone. Operations will adhere to section 7.7.5 of the OGRs.

No areas of concentrated terrestrial lichens were identified during layout.

All known sensitive wildlife sites have been buffered according to section 7.7.6.2 of the OGRs. These buffers have been placed into RAs.

Access and Access Management

Existing access has been utilized where possible to minimize the clearing of new RoW.

The following policies have been implemented to mitigate access management concerns:

Temporary road systems will be closed as soon as possible after the harvesting, hauling, and silviculture activities have been completed.

The following access control practices will also be implemented:

- If a significant delay occurs between harvesting and hauling, temporary access controls on roads will be utilized to restrict access by motorized vehicles. These controls may include the placement of logs on the road, snow berms, and/or removal of creek crossings.

- Slash rollback at strategic points (such as at the ends of the block or at the junction of the temporary road and permanent road) will be completed as soon as possible after logging to discourage access by all terrain or four wheel drive vehicles.

Timing

Since portions of the planning unit falls within a Caribou Range, the timing of operations for those blocks will be completed as per the Alberta-Pacific Caribou Protection Plan.

Since a portion of this planning unit falls within a key Wildlife and Biodiversity Zone, harvest and haul activities within in the zone are to be completed by January 15th as per the OGRs.

6. Spatial Harvest Sequence Summary

The table below summarizes the variance (in area) from the SHS, for Alberta-Pacific harvesting.

The variance exceeds the 20% allowable by cover type for acceptance as per the OGRs.

Non-SHS area has been incorporated into this harvest design in order to create an operationally functionable plan. To offset these additions there is 821.9 ha of Aw defferals and 148.5 ha of Sw deferrals from the SHS from township 87-24-4. This planning unit has been pre-blocked in Alberta-Pacific's 2015 SHS.

Alberta-Pacific has added this area to the schedule in order to achieve it's commitment the Canadaian Boreal Forest Agreement (CBFA).

The percent road class values have been achieved by rounding the road disturbance percent to the nearest whole number.

Block 08723431241 is broken into 4 independent islands that together are greater than 10 ha. The islands contain >2 ha clumps of ≥ 600 stems/ha of White Spruce understorey. Due to road placement and understorey distribution, strip orientation would not be conducive to a windfirm design.

Block 08724402221 is greater than 10 ha and contains >2 ha clumps of \geq 600 stems/ha of White Spruce understorey. Due to the shape of the block and understorey distribution, strip orientation would not be conducive to a windfirm design.

No understorey protection will be submitted for the above 2 blocks.

The possible "Field Call" watercourse classifications are intermittent (I), transitional (T), small permanent (SP), large permanent (LP), lake < 4 ha (SL), lake \ge 4 ha (LL). The "Habitat Rating" identifies watercourses surveyed as fish bearing or potentially fish bearing (SF), surveyed as non-fish bearing (SN) or unsurveyed (U). The "Field Call" watercourse classifications in the above table are based on Table 1 of the OGRs at the time, and during the conditions, when layout was conducted.
