This letter acknowledges that the Owner of the Land has sold or transferred all of its title and interest to all logs (the “Logs”) harvested from the Lands to _____ (the “Seller”). The Owner understands that the Seller has paid or will provide payment directly to the Owner for any Logs removed from the Lands. Alberta Pacific Forest Industries Inc. (“Al-Pac”) is hereby granted access to the Lands for removal of the Logs until such time as all of the Logs are removed from the Lands.

The Owner further acknowledges that any damages to the Lands caused by the Seller are the sole responsibility of the Seller and the Owner will not hold Al-Pac liable for any such damages. The Owner(s), if an individual or individuals, consent to the use and disclosure of their “personal information”, as that term is defined in “the *Personal Information Protection Act* (Alberta) as amended from time to time and any applicable similar, replacement or supplemental provincial or federal legislation or laws in effect from time to time, by the Seller and Al-Pac to confirm the ownership of the Lands.

Al-Pac is committed to maintaining an internationally competitive and sustainable enterprise with minimal effect on the environment. Maintaining forestry certification from the Forest Stewardship Council® (FSC®) and compliance with the European Union Deforestation-Free Regulation (EUDR) aligns Al-Pac’s fibre sourcing policy with these goals.

In this regard, Al-Pac recognizes the important role that forested land plays in mitigating climate change. Additionally, forests can help to stabilize soil, protect riparian areas, mitigate the effects of wind and provide important wildlife habitat. To maintain compliance with the FSC Controlled Wood and EUDR requirements, the signing of this contract confirms the Owner’s acceptance of a Land Assessment included as part of this Schedule D for each harvest area.
